1. Introduction

1.1. Intention and Aims

As a Catholic school within the Benedictine tradition, Glenstal Abbey School is committed to promoting the health, happiness and well-being of each of its students. In our school we live by our core values of Reverence, Respect and Responsibility. We believe in reverence for God and each person uniquely created in God's image, respect for ourselves and others, and responsibility for creating an environment where everyone is safe and cherished. We promote a healthy environment where everyone can grow and flourish. Accordingly substance misuse is incompatible with the culture and ethos of the Glenstal Abbey School.

The school seeks to educate our young people in responsible use of the gifts of creation and medicine, and to educate in an age appropriate way, about the dangers of substance misuse.

The school recognises that parents/guardians are the primary carers and educators of their children, and their support is essential in any prevention strategy. We ask that parents/guardians acknowledge the importance of these programmes and cooperate fully with the school

1.3. Drug Definition

For the purpose of this policy, a drug is any substance which changes the way the body functions mentally, physically or emotionally. It includes over the counter and prescribed medicines, tobacco, cigarettes, alcohol, creatine, solvents, aerosols, plus cannabis, amphetamines, and opioids, and any product or device that may be used to attempt to tamper with a testing sample, and all illegal substances or controlled substances as defined in Irish Law. Possession of any drug paraphernalia which is associated with the use of any drug, substance, chemical or agent, the possession of which is unlawful in Ireland is strictly prohibited and is included in the definition of drugs.

1.4. Dissemination of Policy

This Substance Misuse Policy will be available on the school website. Students will be made aware of this policy as part of their drugs education within the context of SPHE / CSPE lessons

2. Use of Drugs at Glenstal Abbey School

2.1. Jurisdiction of Substance Misuse Policy

This policy applies to all students enrolled in Glenstal Abbey School at all times during the day and night, during school organised/supervised activities/events, regardless of whether or not these activities/events are on or off the school premises and grounds. It also applies when students are travelling to or from these school organised and supervised activities and events. The policy includes all temporary and exchange students.

If a student fails a drugs test as a result of consuming a drug or drugs which he alleges were consumed outside the school grounds, or during a break from school, the school still has jurisdiction to deal with the failing of a drugs test as if the drugs were consumed on the premises.

2.2. Legitimate Medicinal use of Drugs

Glenstal Abbey School does not accept the possession, use or supply of drugs in the school at any time during the school day, or on school organised trips/activities during non-school time by any member of the student community. The only exception is for legitimate medicinal use and the school should be informed in advance.

Students are absolutely forbidden to share prescribed/over-the-counter medication with others.

All controlled drugs should be administered at the Health Centre or by a Housemaster only.

2.3. Supplements

Students at Glenstal Abbey School are encouraged to lead healthy and balanced life-styles where exercise, recreation, rest, sleep and a healthy diet are valued. Sports supplements are not permitted in school and may not be brought into or consumed in school.

3. Alcohol, Tobacco and Drug Education Programmes

3.1. Glenstal Abbey School is committed to providing a comprehensive, timetabled drug education programme for all students.

At Junior Cycle this will be incorporated into the SPHE wellbeing programme currently running in the school.

At Senior Cycle level it will be incorporated into the RE and SPHE wellbeing programmes and, where possible, as part of the Transition Year programme.

SPHE Whole School Approach to Substance Misuse

In line with all educational programmes at Glenstal Abbey School, which emphasise the formation and development of the whole person, SPHE is a programme that provides students with the unique opportunity to develop the skills and competence to learn about themselves and others, to make informed decisions about their health, personal lives and social development. Recognising the significance of addressing substance misuse as a crucial component of a student's health and wellbeing, Glenstal Abbey School has integrated a comprehensive substance misuse education program within the Social, Personal, and Health Education (SPHE) curriculum, at both the Junior Cycle and Senior Cycle. By drawing upon the rich resources offered by the HSE and Department of Education, our SPHE classes are designed to impart essential knowledge and skills related to substance misuse prevention, promoting responsible decision-making, and building resilience among students. Through engaging and age-appropriate activities, our educators aim to empower students with the information and tools needed to make informed choices regarding substance use, fostering a safe and supportive environment for their holistic development.

3.2. Our educational aims in relation to Drug Education are:

- To increase the self-esteem, confidence and wellbeing of our students
- To equip our students with personal and social skills
- To enable students to make wise, healthy, informed choices by increasing knowledge and by challenging attitudes
- To increase understanding of the implications and possible consequences of use and misuse
- To enable students to identify sources of support and intervention

- To help adult members of the school community to recognise the symptoms of substance misuse
- To minimise any harm which might be caused by involvement in a drug incident by offering supportive interventions
- Develop a planned and considered response to incidents involving substance misuse with a view to the protection of the person(s) involved and the maintenance of a safe environment for the wider school community. Due care will be taken in deciding on the balance between a pastoral and disciplinary response.

3.3. These aims will be met in the following way:

- All teachers who wish to be involved with SPHE/CSPE will be actively encouraged to seek appropriate training and will be given the opportunity to avail of it
- Any teacher teaching any Drug Education Programme will be given the opportunity to avail of training
- All teachers and housemasters will be offered Drug Information and Drug Awareness training through dissemination of relevant information and any required in-service training
- Use the outside supports available from the HSE to the school to provide a wide range of supports to the whole school community including health education and promotion, smoking or vaping cessation support, and adolescent counselling services

3.4. Guest Speakers

We believe that trained teachers are in the best position to carry out drug education within the school community, but sometimes it may be appropriate to use an outside speaker to supplement or reinforce the work done in class.

3.5. Parent/Guardians

Opportunities to participate in Drug Awareness Programmes will be made available to parents.

4. Substance Misuse Incidents

4.1. Examples

The following are examples of a substance misuse or suspected substance misuse incident:

- Failing a drugs test
- Emergencies when the person may be unconscious or requires medical assistance

- Suspicion/rumour of drug use, possession or dealing
- Disclosure by another person
- Failure to disclose knowledge of a drug incident to the appropriate authorities
- Possession of a legal/illegal drug on the school premises or on a school related activity
- Selling/supplying legal/illegal drugs
- Attempting to procure drugs on school premises
- School grounds being used for drug or alcohol activity
- Drug paraphernalia found on school property
- Misuse of aerosols, including spray deodorants
- Possession of thinners, petrol, lighters, or any other solvent
- Possession of steroids, stimulants, etc.

Refusal to submit to a drugs test is regarded as a failed drugs test.

5. Banned Substances and Disciplinary Procedures

5.1. Smoking and Vaping

Smoking and vaping are absolutely prohibited, as is the possession of cigarettes, lighters and matches on the school premises, its vicinity and during school functions and activities, including residential activities. For the avoidance of doubt, smoking includes the use of any electronic cigarette or device whose function is to vaporise and deliver to the lungs of the user a chemical mixture typically composed of nicotine, propylene glycol and other chemicals. This also includes the parts of any such device, a cartridge containing a liquid of nicotine and/or other chemicals, a heating element and a mouthpiece. Pipes and shisha pipes are also forbidden.

5.2. Alcohol

The possession, purchase, supply to another, or drinking of alcohol is absolutely forbidden on the school premises, its vicinity, and during school functions and activities. Sixth Year students, who are aged 18 or older, may be permitted to drink alcohol during certain school functions such as the Leavers' Dinner, at the discretion of the Headmaster.

5.3. Illegal Drugs

In Glenstal Abbey School, the possession, purchase, supply to another, or consumption of illegal substances (drugs) during the school day or during school activities, events or trips is strictly forbidden and will also be subject to disciplinary action.

5.4. Solvents

Aerosols, solvents and indelible markers are not to be brought to school and may be confiscated.

5.5. Suspicion of Misuse

Where a student is suspected of being in possession of illegal substances, the school may conduct a search and this may include asking a student to empty his pockets, to open lockers, bags etc. so that a search can be carried out. A full record of any confiscated items will be kept and they will be retained in a secure place pending the completion of any investigation. Any drugs will be passed to An Garda Síochána. Parents/guardians will be informed.

5.6. Procedure to be followed in the event of a Substance Misuse Incident

 If drug use is suspected, a nurse should be contacted to evaluate the student's condition (over the phone if not on site / on call service) and advise if the student requires medical attention and / or is in immediate danger

- Where there is an immediate danger to the person concerned, staff will call an ambulance immediately. The Member of staff will inform the Deputy Head / Deputy Principal as soon as possible
- In any case where it is apparent that there is an immediate danger to other students or the whole school community, the Principal and Headmaster, or the Deputy Principal / Deputy Head, will arrange the removal of student from the premises and/or from any specific school activities
- In all cases a full investigation will take place in accordance with the school's disciplinary procedures
- The parents/guardians should be notified as soon as possible
- Great attention should be taken for personal health and safety when dealing with a confirmed incident involving illegal substances and drug paraphernalia. In the event of an incident the area will be sealed off and secured until the arrival of the Gardaí

5.7 Returning to school

Any student accepted back to school following involvement in a confirmed substance misuse incident may be asked to comply with a period of assessment, which will be monitored by the Deputy Principal / Deputy Head, during which the student may be required to:

- attend counselling to be organised and paid for by their parents
- submit to regular drug testing

Prior to testing, the student will be asked to sign a consent form and consent will be formally sought and noted from the parent/guardian.

A clear agreement will be drawn up between the Headmaster and the student's parents, placing the student on probation. The student must show that he is committed to staying away from any involvement in substance misuse.

5.8 Confidentiality

The prime focus in any incident relating to a student is the wellbeing of the student. The need for great care in this area is recognised, as the student may approach a teacher because they trust her/him and need help. It is important that in all suspected or confirmed drug incidents that a limited number of people are involved in managing the incident. People will be informed on a "Need to

Know" basis. The Headmaster, Deputy Principal / Deputy Head, Nurses, Guidance Counsellor, Deans, and person/s directly involved in the case will be informed, and all written documentation will be held confidentially by the Deputy Head. The student will be informed about what is happening and why.

5.9 Parents/Guardians

Parents/Guardians will always be informed if there is a substance misuse incident in the school and of the disciplinary consequences. Whenever possible support and /or intervention will be offered to the student(s) In the first instance, this support will be offered by the Guidance Counsellor.

5.10 Gardaí

The Headmaster & Principal / Deputy Principal / Deputy Head / Deans or a designated person, reserve the right to contact the Gardaí or the Juvenile Liaison Officer (JLO) in the event of a confirmed incident involving illicit substances.

5.11 Counselling and Pastoral Care:

The school may ask that other agencies be involved once confirmation of an incident has taken place: i.e. HSE. Drug testing; Counselling; G.P. etc.

In response to all incidents pastoral support will be offered and in some cases parents may be asked to arrange a referral to a substance misuse counsellor.

6. Training

The Board of Management of Glenstal Abbey School has a strong commitment to ongoing staff training. Up to date information and resources need to be available to the whole school community.

6.1. Staff

The school will make available training to staff involved in delivering Social, Personal and Health Education Programmes. All teachers and housemasters will be offered drug information and awareness training. First-Aid training will be offered to all staff.

7. Drug Testing

- 7.1. Drug and alcohol testing on the basis of a reasonable suspicion for all students
 - If any student is suspected of being under the influence of drugs or alcohol, or may have violated the prohibited use or consumption, possession, selling, buying, manufacturing, transferring or dispensing of unauthorised drugs or alcohol the suspected behaviour will be documented by a Staff member.

- The student will be given an opportunity to explain the behaviour and the explanation will also be documented.
- As part of the investigation of such suspected behaviour, the school may require any student to undergo on the spot drug and/or alcohol 'narrow window' testing via a breath or saliva sample. The test(s) will be administered by a member of the Student Support Team or Houseparent team..
- The school may also require a student to have a regular test as part of a disciplinary procedure.
- Refusal to take a test is treated as a failed drugs test.
- The cost of testing will be billed to the student's expense account only if the test results are positive.

8. Review and Evaluation

The policy will be reviewed annually, or in the light of changing information, by the Board of Management.
